#### **Processing**

#### The processing and material temperature should be between 68-77°F (20-25°C).

For best results, de-air the material prior to casting, then pressurize to 60 psi until cured. If pigment has been added to the hardener component, it will separate during storage.

Agitate hardener before mixing to ensure that the formula is homogeneous.
